# DRAFT CENTRAL HIGHLANDS LOCAL PROVISIONS SCHEDULE RESPONSE TO COMMISSION CORRESPONDENCE DATED 8 MARCH 2022

I refer to the correspondence from the Tasmanian Planning Commission dated 8 March 2022 pertaining to the Central Highlands Draft Local Provisions Schedule and advise the following.

### Direction No. 1.1, (a) and (b):

The Planning Authority is pursuing the engagement of a suitably qualified person to undertake the requested peer-review. The consultants that have undertaken this type of work for other planning authorities through the development of the Local Provisions Schedule have verbally advised that they would not be able to undertake this work for Central Highlands for four months due to their high workload. We are seeking confirmation of this in writing. We are also investigating other agricultural consultancy options.

In light of this, the Planning Authority requests a four-month extension to the due date.

### Direction No. 1.1, (c):

- (i) The Priority Vegetation Area would apply to land zoned Rural. This is an aspect of the State Planning Provisions that the Planning Authority understands cannot be changed. The GIS-format maps accessed through the link in the email accompanying this letter show this overlay.
- (ii) A list of properties proposed to be modified from the exhibited Agriculture Zone back to the Rural Zone is provided in the link in the email accompanying this letter. This information is provided as an excel spreadsheet. The number of parcels totals 584, which includes 391 private freehold parcels.

(iii)&(iv) Noting advice from the Commission that directions 1.1(c)(iii) & (iv) do not constitute a direction to undertake a new landowner consultation exercise, the written evidence is that which has already been forwarded to the Commission by way of the representations received during the public notification period.

It is noted that if the four-month extension of time sought above in response to 1.1(a) & (b) is granted, there would be time to undertake a landowner consultation exercise.

### Direction No. 1.2, (a) & (b):

The 'landscape protection' land identified with the yellow shading in the zone maps shown on pages 48-65 of the Section 35F Report refers to recommended changes of zone to Landscape Conservation. These recommended changes are set out in the Planning Authority's responses to various representations wherein certain landowners with conservation covenants requested a change to this zone. The PDF maps accessed through the link in the email accompanying this letter have been amended to reflect the correct annotation "Amend to Landscape Conservation Zone".

# AMENDED PLANNING PERMIT DA 2009/18

In accordance with Division 2 of Part 4 of the Land Use and Planning Approvals Act 1993, the Central Highlands Council (Planning Authority) grants an amended permit –

To: Peacock Darcey & Anderson P/L

Of: 127 Bathurst Street HOBART TAS 7000

#### For land described as:

P45 Dennistoun Road & 1 Elizabeth Street, Bothwell (CT 126111/1, 123457/4, 149019/1, 123548/1, 126113/3 and 141298/1)

### This amended Permit allows for:

The land to be developed by the subdivision of 17 lots and boundary adjustments and associated site works in accordance with the information and particulars set out in the development application and endorsed drawings.

#### THE FOLLOWING CONDITIONS APPLY TO THIS AMENDED PERMIT: -

Planning

- 1. The subdivision layout or development shown on the endorsed plan of survey and specified in the associated application information must not be altered without the further written consent of Council.
- 2. The final plan of survey lodged with Council must depict:
  - the combination of Lots 1 and 2 to form a single lot; and
  - the combination of Lots 17 and 16 to form a single lot, resulting in a total of fifteen (15) lots to be crated within the Village Zone.
- 3. The subdivision may proceed in stages, to be determined by the developer. Services and road works are to be completed for each stage as necessary in accordance with the conditions of this permit. A final approved plan of survey and schedule of easements (as required) together with two (2) copies of same must be submitted to Council for sealing for each stage. The final approved plan of survey must be substantially the same as the endorsed plan of subdivision that forms part of this permit and must be prepared in accordance with the requirements of the Recorder of Titles.
- 4. Easements must be created over all drains, pipelines, wayleaves and services in accordance with the requirements of the Municipal Engineer. The cost of locating and creating the easements shall be at the subdivider's full cost.

- 5. All roads or footways must be shown as "Road" or "Footway" on the final plan of survey and transferred to the Central Highlands Council by Memorandum of Transfer submitted with the Final plan of Survey.
- 6. A report by a suitably qualified professional is to be submitted to Council prior to sealing the Final Plan of Survey to show that there is no chemical residue on Lots 1-17 that would make the land unsuitable for residential use. If any such chemical residue is identified remedial action must be completed prior to the development proceeding.
- 7. As insufficient provision has been made for recreational space, and having formed the opinion that such a provision should be made in respect of the proposal, Council requires that an amount equal to five percent (5%) of the unimproved value of Lots 3 12 and 14, 16 & 17 (combined per Condition 2 of this permit) must be provided as cash-in-lieu of public open space in accordance with the provisions of Section 117 of the Local Government (Building & Miscellaneous Provisions) Act 1993. The subdivider must obtain a valuation for the unimproved value of the subdivision from a registered Valuer or other approved method.
- 8. The cash-in-lieu of public open space must be in the form of a direct payment made before the sealing of the final plan of survey or, alternatively, in the form of a Bond or Bank guarantee to cover payment within ninety (90) days after demand, made after the final plan of survey has taken effect.
- 9. An agreement pursuant to Part 5 of the Land Use Planning and Approvals Act 1993 must be entered into prior to the sealing of the final plan of survey regarding the fifteen (15) lots located within the Village Zone to require:
  - a. That all future development of lots 1 & 2 (combined per Condition 2 of this permit), 3, 4, 5, 6, 7, 12, 13 and 16 & 17 (combined per Condition 2 of this permit) is strictly limited to the construction of a single dwelling and structures ancillary to a single dwelling only. For the avoidance of doubt, this limitation will not apply to lots 8, 9, 10, 11, 14 and 15;
  - b. Any future application for development and/or works on the lots shall be accompanied by a schedule specifying the finish and colours of all external surfaces submitted to and approved by the Council. The schedule must provide for finished colours that blend in with the natural rural landscape and minimise visual intrusion, such as natural browns or greens.
  - c. Any future application for development on the lots shall be designed to harmonise with the traditional character of the area.
  - d. The external building materials of any residential dwelling must not exceed 25% Colorbond or similar material.
  - e. Native vegetation must not be removed, destroyed or lopped on the lots without first obtaining separate Council planning approval;
  - f. Front lot boundaries are not to be fenced with Colorbond sheeting or similar materials. Fencing materials and design are to be submitted to and approved by the Council prior to construction.

- g. Front fences on the lots must not exceed 1.2 metres in height.
- 10. Agreements made pursuant to Part 5 of the Land Use Planning and Approvals Act 1993 must be prepared by the applicant on a blank instrument form to the satisfaction of the Council and registered with the Recorder of Titles. All costs associated with the preparation and registration of the Part 5 Agreement must be met by the subdivider.
- 11. The road reserves must be landscaped by trees or plants in accordance with a landscape plan prepared by a landscape architect or other person approved by Council, and submitted to Council for endorsement with the engineering drawings. The landscape plan must show the areas to be landscaped, the form of landscaping, and the species of plants and estimates of the cost of the works. Planting shall be equivalent to a minimum of 1 tree per lot using advanced plants that suit the character of the locality. The landscaping should include a row of trees adjacent to the northern boundaries of Lots 3, 8, 9, 10, 11, 14 and 15. No plants listed as noxious weeds within Tasmania, or displaying invasive characteristics shall be used in the landscaping of the road.
- 12. The topsoil on any areas required to be disturbed must be stripped and stockpiled in an approved location shown on the detailed soil and water management plan for reuse in the rehabilitation of the site. Topsoil must not be removed from the site until the completion of all works unless approved otherwise by the Municipal Engineer.
- 13. All disturbed surfaces on the land, except those set aside for roadways, footways and driveways, must be covered with top soil and, where appropriate, re-vegetated and stabilised to the satisfaction of the Municipal Engineer.
- 14. Any accumulation of vegetation, building debris or other unwanted material must be disposed of by removal from the site in an approved manner. No burning of such materials on site will be permitted unless approved in writing by the General Manager.
- 15. This permit shall not take effect and must not be acted on until a Soil and Water Management Plan (SWMP) prepared by a consultant approved by the Municipal Engineer recommending measures to control stormwater runoff from the land so that runoff does not cause erosion and sedimentation or discolouration of any surface water outside the boundaries of the land during the construction phase in accordance with HMCA: Guidelines for Soil and Water Management, HMCA, Hobart, 1999 and the State Policy for Water Quality Management 1997 has been submitted to and approved by the Council's General Manager (refer to advice below).
- 16. Prior to any other works approved by this permit commencing, install temporary run-off, erosion and sediment controls in accordance with the recommendations of the approved SWMP and maintain full operational capacity until the land is effectively rehabilitated and stabilised after completion of the development to the satisfaction of the General Manager.
- 17. All works associated with the development of the land must be carried out in such a manner so as not to cause injury to, or prejudicially affect the amenity, function and safety of any adjoining or adjacent building, and of any person therein or in the vicinity thereof, by reason of:

- (a) Emissions from activities or equipment related to the use or development, including noise and vibration, which can be detected by a person at the boundary with another property.
- (b) Transport of materials, goods or commodities to or from the land.
- (c) Appearance of any building, works or materials.
- 18. The development must be carried out between the following hours:

  Monday to Friday
  Saturday
  8:00 AM to 6:00 PM
  9:00 AM to 6:00 PM

Sunday and State-wide public holidays 10:00 AM to 6:00 PM

- 19. Public roadways or footpaths must not be used for the storage of any construction materials or wastes, for the loading/unloading of any vehicle or equipment, or for the carrying out of any work, process or tasks associated with the project during the construction period.
- 20. A fee of \$100.00, or as otherwise adopted by Council resolution from time to time, must be paid to Council prior to the sealing of each stage of the final plan of survey.
- 21. A final plan of survey and two (2) copies must be provided together with the schedule of easements as necessary.
- 22. All conditions of this permit must be satisfied before the Council seals the final plan of survey for each stage. It is the subdivider's responsibility to arrange any required inspections and to advise Council in writing that the conditions of the permit have been satisfied. The final plan of survey will not be dealt with until this advice has been provided.
- 23. Prior to Council sealing the final plan of survey, security for a value clearly in excess of any outstanding works and maintenance required by this permit, must be lodged with the Central Highlands Council. The security must be in the form of section 86(3) of the Local Government (Building & Miscellaneous Provisions) Act 1993. The value of the security must be determined by the General Manager following approval of any engineering drawings and not be less than \$5,000.

### Engineering General

- 24. All services are to be sized and located to service the ultimate potential development of the site.
- 25. The Subdivider must pay the cost of any alterations and/or reinstatement to existing services, Council infrastructure or private property incurred as a result of the proposed subdivision works. Any work required is to be specified or undertaken by the authority concerned.
- 26. All new public infrastructure and subdivision work must be designed and constructed in accordance with the statutory requirements in the:-
  - Local Government (Building & Miscellaneous Provisions) Act 1993
  - Local Government (Highways) Act
  - Sewers & Drains Act 1954
  - Waterworks Clauses Act
  - Australian Standards
  - Building and Plumbing Regulations
  - Relevant By-laws and Council Policy

 Current IPWEA and Central Highlands Council Municipal Standard Drawings

 Current IPWEA and Central Highlands Council Municipal Standard Specification

#### Other utilities

27. Electrical and telecommunication services must be provided to each lot in accordance with the requirements of the responsible authority and to the satisfaction of the Municipal Engineer.

Design drawings

- 28. Engineering design drawings are to be prepared by a qualified and experienced civil engineer, or other person approved by the Municipal Engineer.
- 29. All engineering plans are to be prepared in accordance with AS1100.101 "Technical Drawing General principles" and AS1100.401 "Technical Drawing Engineering survey and engineering survey design drawing".
- 30. Two sets of engineering plans are to be submitted to Council for initial inspection and comment. Four (4) sets of engineering plans are to be submitted for final approval by Council. Council will keep two (2) sets of approved plans and two (2) sets will be returned to the developer's engineer.
- 31. Approved Engineering Plans will remain valid for a period of 2 years from the original date of approval.

Drainage

- 32. Stormwater drainage though private property is to be piped unless approved otherwise by the Municipal Engineer.
- 33. Separate stormwater connections must be supplied to each lot in accordance with Council standards and specification and the requirements of the Municipal Engineer.

#### Southern Water Conditions

- 34. The proposed subdivision must be provided with adequate fire protection (at the developer's cost) to Australian Standards and the Tasmania Fire Service requirements. In addition to adequate provision within the subdivision as shown on the proposal plan (Services Plan H-1258C-4 Version B dated 23 June 2010), the following infrastructure is required to be designed and constructed by the developer at the developer's cost prior to sealing the plan for the second stage of the subdivision:
  - Install a new DN 100 water main along the Elizabeth Street from the existing DN100 water main in Barrack Street to James Street and provide a DN50 link across Elizabeth Street to James Street;

In addition to adequate provision within the subdivision as shown on the proposal plan prior to the sealing of the plan for the subdivision the following infrastructure is required to be designed and constructed by the developer. Southern Water must pay one half of the cost of this infrastructure:

• Install a new DN200 water main link along the Western side of Barrack Street from the existing DN200 water main in front of No. 2 Barrack Street up to the existing DN100 water main at the intersection of barrack Street and Alexander Street.

Note: Condition 34 amended on the 16 August 2012 pursuant to Section 56 of the Land Use Planning and Approvals Act.

- 35. Where 120 metres reach from a fire hydrant cannot be achieved within individual lots, building envelopes shall be included on affected lot highlighting the limits of the area that can be provided with adequate fire protection from the proposed water main infrastructure.
- 36. A 20mm nominal size water connection is to be provided to the boundary of each lot (including upgrading any existing property services within the development) with an individual 20mm diameter meter with integral dual check valve. Connections to existing mains are to be carried out by Southern Water at the developer's cost. Southern Water shall supply all water meters. The developer shall make application for these works and meters by using form WS01A WS Related works Application for Water and Sewerage.
- 37. The developer must pay to Southern Water Developer Charges of \$600 per lot (created in the village zone) for sewage pump station infrastructure downstream prior to Southern Water endorsing the Plan of Survey prior to the sealing by Council with Southern Water's Developer Charge Policy. The charge is to be indexed quarterly at the Consumer Price Index, All Groups Hobart rate from the date of this permit until the date it is paid to Southern Water.
- 38. A 150mm nominal size sewer with 100mm nominal size sewer connections at the low point of each lot must be provided. If the connection cannot be achieved at the low point, building envelopes shall be included on the title for each affected lot highlighting the limits of the area that can be connected by gravity into the proposed sewerage infrastructure.
- 39. Any existing water and sewerage services on the land are to be contained within a single allotment. Should any services extend beyond the property boundary these services shall be replaced within the single affected lot at the developer's cost.
- 40. Easements in the name of Tasmanian Water and Sewerage Corporation (Southern Region) Pty Ltd must be shown on the Plan of Survey and be over all proposed pipelines. The minimum easement width shall be 2.5m. The minimum easement width for two pipes within the easement shall be 3.0m and the easement must be in the name of the Council and the Tasmanian Water and Sewerage Corporation (Southern Region) Pty Ltd.
- 41. Prior to commencement of any works on site, the developer shall make an application to Southern Water for a Certificate for Certifiable Work (Plumbing).
- 42. "As constructed" drawings for all services and connections in both hard copy and digital formats must be provided to Southern Water prior to the works being placed on maintenance. Digital format must be in a format acceptable to Southern Water.

- 43. The Applicant must take care to protect Southern Water's assets. Any damage to Southern Water assets must be promptly reported to Southern Water and will be repaired at the developer's cost.
- 44. Prior to issue of a Certificate of Certifiable Work (Plumbing) from Southern Water, the developer must lodge with Southern Water for approval engineering design plans prepared by a registered professional engineer at the developer's cost showing the hydraulic servicing requirements for water and sewerage. The engineering design plans must comply with the Sewerage Code of Australia and the Water Code of Australia Melbourne Retail Agency Versions published by the Water Services Association of Australia and be to the satisfaction of Southern Water Executive Manager Asset and Service Strategy. Refer to advice below.

### Access and roads

- 45. Roadworks and drainage must be constructed in accordance with the standard drawings prepared by the IPWE Aust. (Tasmania Division) and to the satisfaction of the Municipal Engineer. Roadworks must include:
  - (a) Elizabeth Street
    - 6.00 metre wide sealed pavement;
    - Concrete kerb and channel on the northern side;
    - Underground drains;
    - Compacted gravel footpath on one side.
- 46. A pavement design must be submitted for approval with the engineering plans. The pavement design shall be in accordance with ARRB Special Report No. 41 using the estimated traffic volumes, the expected traffic type and the sub-grade California Bearing Ratio (CBR). The subgrade CBR values must be determined from laboratory tests, or other method approved by the Municipal Engineer, and must be based on a minimum of three (3) separate samples for each street.
- 47. A reinforced concrete access must be provided from the carriageway of the road to each lot on the plan in accordance with the construction and sight distance standards shown on standard drawings SD 1003 and SD 1030 prepared by the IPWE Aust. (Tasmania Division) and to the satisfaction of Council's Municipal Engineer.
- 48. All driveway carriageways providing shared access to more than one lot must be constructed in accordance with Section 107 of the Local Government (Buildings and Miscellaneous Provisions) Act 1993, and municipal standard drawings. Shared access must include a:
  - maximum grade of 1 in 5 (20%) onto the lot;
  - minimum trafficable width of 3.00 metres;
  - minimum compacted pavement depth of 200 mm;
  - surface consisting of a 10 mm nominal size two-coat bituminous seal;
     and
  - stormwater drainage and culverts as required.

#### Construction

49. A Traffic Management Plan prepared by a suitably qualified person in accordance with Section G2.6 of DIER: Standard Specification for Roadworks, Department of Infrastructure, Energy and Resources, Hobart, August 2003 and the referenced document DIER: Traffic Control at Work Sites Code of Practice, Department of Infrastructure, Energy and Resources, Hobart, June 2004, or the current replacements must be submitted to the Municipal Engineer prior to the commencement of any

work within a public road reserve. All traffic control is required to be performed and certified by accredited traffic control personnel and all works within the road reserve to comply with all relevant occupational health and safety regulations.

- 50. Prior to the development of the land commencing on site or within a council roadway, a "start work" notice must be lodged with and accepted by the Municipal Engineer. The "start work" notice must be accompanied by evidence of payment of the Building and Construction Industry Training Levy, where the cost of the works exceeds \$12,000.
- 51. Not less than 48 hours written notice must be provided to Council before reaching any stage of works requiring inspection by Council unless otherwise agreed by the Municipal Engineer.
- 52. The subdivision must be placed onto a 12 month defects liability period in accordance with Councils Specification and Policy following the works reaching the stage of practical completion in accordance with the approved engineering plans and permit conditions.
- 53. Prior to the works being placed on the maintenance period an "as constructed" drawing must be provided to the satisfaction of the Municipal Engineer of all engineering works provided as part of this approval. These drawings must be prepared by a qualified and experienced civil engineer or other person approved by the Municipal Engineer and provided in both digital and "hard copy" format.

### THE FOLLOWING ADVICE APPLIES TO THIS AMENDED PERMIT:

- 1. This permit does not imply that any other approval required under any other legislation or by-law has been granted.
- 2. The owner is advised that a fee of 1% of the value of the approved engineering works, or a minimum of \$200.00, must be paid to Council in accordance with Council's fee schedule.
- 3. The traffic management Code of Practice can be found at <a href="http://www.transport.tas.gov.au/safety/traffic\_control\_code/index.html">http://www.transport.tas.gov.au/safety/traffic\_control\_code/index.html</a>. Typical details are shown in the relevant Australian Standard field guide.
- 4. The SWMP must show the following:
  - Allotment boundaries, north-point, contours, layout of roads, driveways, building envelopes and reticulated services (including power and telephone and any on-site drainage or water supply), impervious surfaces and types of all existing natural vegetation;
  - Critical natural areas such as drainage lines, recharge area, wetlands, and unstable land;
  - Estimated dates of the start and completion of the works;
  - Timing of the site rehabilitation or landscape program;
  - Details of land clearing and earthworks or trenching and location of soil stockpiles associated with roads, driveways, building sites, reticulated services and fire hazard protection;
  - Arrangements to be made for surface and subsurface drainage and vegetation management in order to prevent sheet and tunnel erosion;
  - Temporary erosion and sedimentation controls to be used on the site;
     and

Appropriate temporary control measures include, but are not limited to, the following:

Minimise site disturbance and vegetation removal;

 Diversion of up-slope run-off around cleared and/or disturbed areas, or areas to be cleared and/or disturbed, provided that such diverted water will not cause erosion and is directed to a legal discharge point (eg. temporarily connected to Council's storm water system, a watercourse or road drain);

Sediment retention traps (e.g. sediment fences, straw bales, grass turf
filter strips, etc.) at the down slope perimeter of the
prevent unwanted sediment and other debris escaping from the land;

• Sediment retention traps (e.g. sediment fences, straw bales, etc.) around the inlets to the stormwater system to prevent unwanted sediment and other debris blocking the drains;

Rehabilitation of all disturbed areas as soon as possible.

5. This planning approval shall lapse at the expiration of two (2) years from the date of the commencement of planning approval if the development for which the approval was given has not been substantially commenced. Where a planning approval for a development has lapsed, an application for renewal of a planning approval for that development shall be treated as a new application.




