**Notice of extension of time for representors and other parties to respond to a further submission from the applicant of 2 May 2023**

I refer to the above draft amendment and to a hearing held at the Paranalpe Centre in Devonport on 6 and 7 March 2023, which was adjourned.

Following the hearing, on 3 April 2023, the Commission issued a direction requesting the planning authority and applicant provide a range of information by 28 April 2023 and inviting representors to respond by 12 May 2023.
