In addition the Commission must, under section 22 of the Act, prepare a draft integrated assessment report in consultation with each such agency (and the Hobart City Council). The draft has to be placed on public exhibition and advertised.

Please note that the Commission has not yet commenced the integrated assessment. It will commence when the Macquarie Point Development Corporation has provided to the Commission all the reports relied on by the Corporation.

The Commission has determined Kingborough Council to be a relevant agency with an interest in the Macquarie Point multipurpose stadium. A number of others have likewise been determined to be an 'agency'.

This letter is to advise at an early stage how the integrated assessment process for the project will include Kingborough Council and to provide forewarning, to allow Kingborough Council to plan for their involvement.

In due course the formal notice under section 21(1) of the Act will be given. Accompanying will be the reports from the Macquarie Point Development Corporation.

As noted, the Commission is required to consult with Kingborough Council in the preparation of a draft integrated assessment report. To that end, the Commission will hold meetings with the agencies as required, including to explore matters raised in their submissions.
