While the owners name associated with the with the property at 4053 East Tamar Highway (FR 152399/2) is listed as Alita Energy (Tamar Valley) Pty Ltd, the name of the controlling entity has changed over time is now listed at AETV PTY LTD. This is a subsidiary of the Hydro-Electric Corporation (T/A Hydro Tasmania). The change of controlling entities is shown Table 1 below and outlines history of the property and asset owners names since 2007.

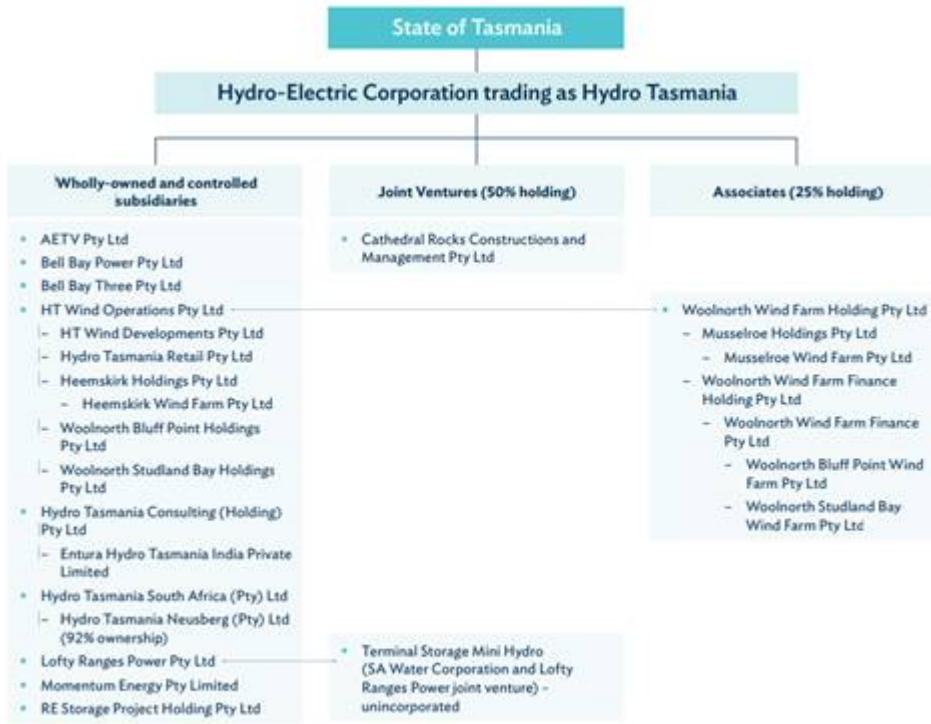
As shown, the property and assets were previously owned by Alita Energy, Aurora Energy, and now Hydro Tasmania.

The transfer of the Alinta Energy (Tamar Valley) Pty Ltd, including the plant, equipment and land (FR 152399/2) on which the Tamar Valley Power Station were located, was transferred to Aurora Energy under the *Tamar Valley Power Station Act 2008*. This was followed by the transfer to Hydro Tasmania via the *Electricity Reform Act 2012*. The ownership of AETV PTY LTD is shown in the overview Hydro Tasmania’s corporate structure below.
