Huon Valley Draft Local Provisions Schedule (LPS)

Hearings are to be held on the representations made on the Huon Valley draft LPS and the recommendations in the planning authority's report under section 35F of the *Land Use Planning and Approvals Act 1993* (the section 35F report). The delegate Panel for the draft LPS assessment is John Ramsay (chair), Nick Heath and Dan Ford.

The Commission will initially hold a directions hearing to which all parties, including the planning authority and representors are invited. While it is expected that the planning authority will attend, representors may attend if they wish. Non-attendance at the directions hearing, does not affect future consideration of a representation.

The purpose of the directions hearing is to outline the arrangements for hearings into the representations, to explain the Commission's processes and to respond to any queries representors or the planning authority may have about the process. The merit of representations is not considered at the directions hearing. The directions hearing will be held on **Tuesday, 21 March 2023** at 10am at the Huonville Town Hall, 40 Main Street Huonville.
