### Scenic Protection Area — S8A Guidelines

#### Guidelines for applying the Scenic Protection Code overlays

- SPC 1 The scenic protection area overlay and the scenic road corridor overlay may be applied to land identified at the local or regional level as important for the protection of scenic values. These may include areas:
  - (a) containing significant native vegetation or bushland areas with important scenic values (such as skyline areas); or
  - (b) identified for their significant scenic views.
- SPC 2 The scenic protection area overlay and the scenic road corridor overlay should be justified as having significant scenic values requiring protection from inappropriate development that would or may diminish those values.





# Scenic values context

- Local area character and scenic values are defined by patchworks of cleared and occupied land <u>up</u> <u>to and beyond</u> the elevation of the subject site
- The Crouchs Hill Ridgeline is dominated by the more prominent Mount Ruddy area which is cleared and developed.




# Cultural landscape – includes patchworks of clearings at elevation




# Scenic values context

- Valley floor at 120-130m in surrounding area
- Subject site extends 250-350m
- Nearby Mount Ruddy area is cleared, occupied with prominent/visible south-facing aspects 360-440m
- There are extensive cleared and occupied areas at equivalent and higher elevations and in more prominent locations across the Crabtree valley and around the Huon Valley more generally










