Hi Linda,

Thanks for your email. I can confirm that we've not heard any consultation from the Planning Authority on Directions 25 or 52.

We are comfortable with the proposed zoning and PVA Overlay boundaries as presented on the attachments you sent for these 2 titles (117161/2 & 224515/1).

The fourth point in the Cluster 52d document is a little concerning as it relates back to remotely-obtained data with less accuracy and currency than the field-checked GPSed data that Dion and I have provided. But I spoke with HVC's Rong Zheng today and he confirmed that HVC and their consultant are still working through Direction 51 on the remaining titles, and so we'll wait to see what approach they use there.

We have received advice from the planning authority in relation to Directions 25 and 52 which were triggered by your representations (representation 343 and 344). Revised mapping was received in August.

We have noted that the directions required the planning authority to consult with you in regard to any zone or overlay revision.

Are you able to confirm whether the planning authority consulted with you in regard to Directions 25 and 52? If not, are you able to provide comment in relation to the proposed application of the Rural Zone and the Priority Vegetation Area overlay. For your information, the Commission has notified the affected landowners of the possible revisions.

Also, just to update you. Due to various reasons, the hearings are likely to resume in the second week of February 2024 rather than at the end of this month.
