The map below at Fordington with the small x is Public Reserve CL so EMZ should be applied as it has legislated management objectives similar to reserved land.

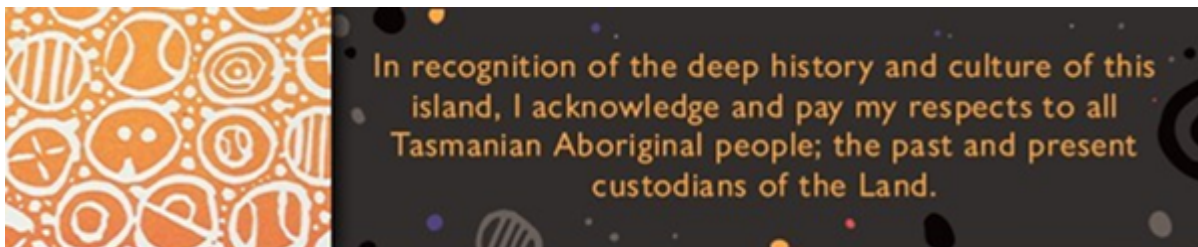
The Derby map below with the ? mark is Public Reserve CL so EMZ should be applied as it has legislated management objectives similar to reserved land .

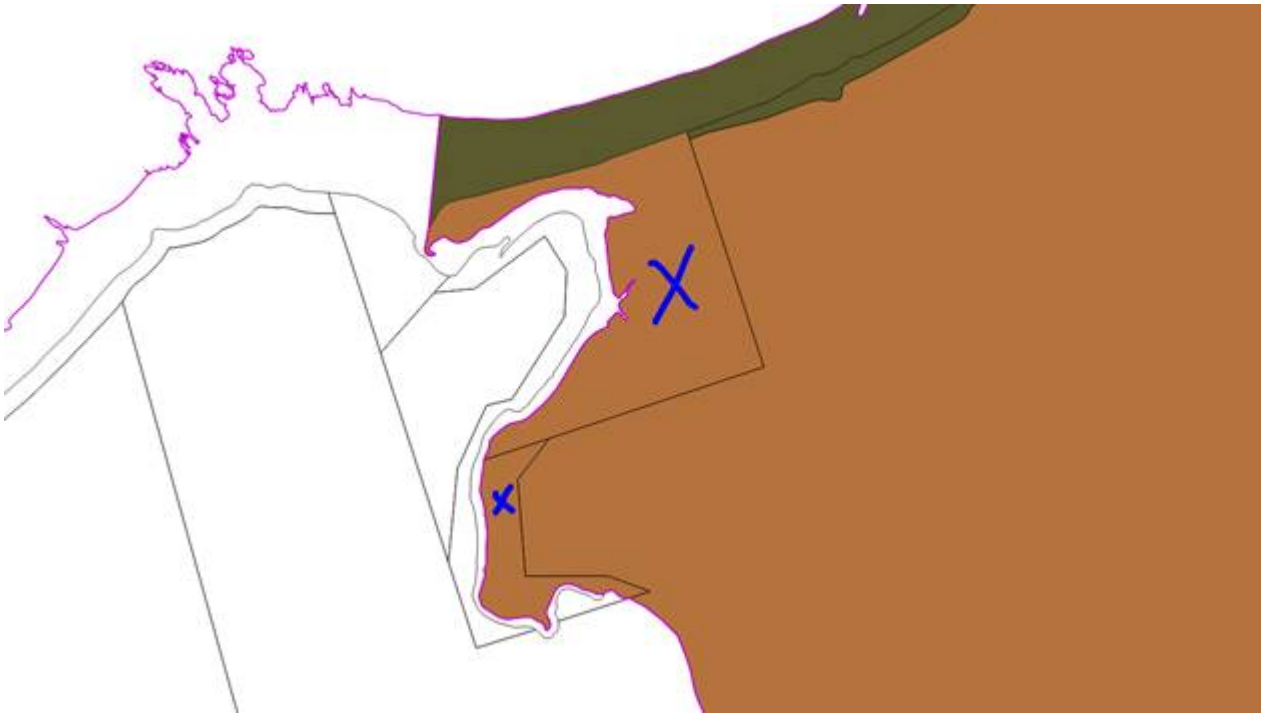
