Hi Paola

I can confirm that Council did receive Mr. Boardman's submission. Unfortunately due to an administrative error the submission was filed incorrectly and was not considered in the planning authority's section 40K report.

However, representations from Mr Boardman's client, Ramilya Khayrutdinova, and from surveyor David Potter, about the property at 9 Melinda Ct were considered as "Rep 5" in the s.40K report.

It is noted that Mr. Boardman's submission questions the need for the SAP to be included as part of the planning scheme amendment and rather the land should be simply rezoned to General Residential. The reasons for the need for the SAP and how the SAP will function is clearly set out in Council's s.40F(1) report. Most notably Policy SRD 2.5 of STRLUS promotes precinct structure planning.

Council identified the need for a SAP and has committed resources to the preparation of the Master Plan for a number of years. It is unlikely that the planning authority would have considered the matter differently had Mr. Boardman's representation been considered in the s.40K report.

I would hope that Mr Boardman be invited to attend the hearings and his concerns can be considered more fully by the Panel at this time.


