I write in relation to the abovementioned development application that is currently on public exhibition. Please consider this submission as a representation on behalf of the Tasmania Fire Service.

The application seeks to amend the Clarence Local Provision Schedule (LPS) by rezoning the subject site from Community Purpose Zone to General Residential Zone, Open Space Zone and Utilties Zone, and undertake a 7-lot subdivision.

The proposed subdivision involves land within a designated 'bushfire-prone area' (as defined in clause C13.3.1). Clause C13.2.1 specifies that section C13.0 Bushfire-Prone Areas Code applies to the subdivision of land within a 'bushfire-prone area'.

To satisfy the Bushfire-Prone Areas Code, the application must be supported by one of the following:

- Certification from an accredited person that the proposal involves an insufficient increase in risk, in which case the application would be exempted under clause C13.4.1(a) from further consideration under the Code; or
- A bushfire hazard management plan that demonstrates compliance with the development standards of clause C13.6 and is certified by an accredited person.

It is understood that the application includes neither a certified exemption nor a certified bushfire hazard management plan. Therefore, the application does not meet the exemption criteria under C13.4.1 and does not satisfy the development standards of clause C13.6.

The Planning Scheme does not provide the planning authority with discretion to waive the requirement for the applicant to provide one of the above.

The plan is not compliant with the *Chief Officer's Approved Form for a Bushfire Hazard Management Plan*, is not supported by a compliant bushfire hazard report and is not certified by an accredited person. The plan contains a range of technical deficiencies including:

- Failure to provide BAL-19 building areas for all lots in the subdivision;
- Provision for BAL-29 buildings on Lot 7;
- No specifications for hazard management areas;
- · No specifications for access design;
- No specifications for firefighting water supplies.
- Non-compliant cul-de-sac head dimensions.

The planning report (p.30) incorrectly states that the plan has been certified by an accredited person, in response to clause C13.6.1. Further, the report (p.31) incorrectly state that the subdivision has been exempted from the access requirements of clause C13.6.2 and is silent with respect to water supply requirements of clause C13.6.3.

Consequently, the application fails to comply with section C13.0 of the Tasmanian Planning Scheme. It is likely the subdivision layout will require modifications to achieve Code compliance. It is TFS's view that the application should not have been exhibited without a certified bushfire hazard management plan and should not be approved in its current form.
