# Tasmanian Planning Scheme – Clarence Draft amendment PDPSPAMEND-2021-019004 and combined permit 30 Holland Court, Howrah

Dear Ms Hynes,

Thank you for the further directions of 27 September 2023, in relation to the above matter before the Commission.

Council has received advice from the applicant that there will be a delay in providing the BHM Plan, please refer to Attachment 1. It appears unlikely that the 19 October 2023 deadline will be achieved.

The applicant has not provided a new time frame for when the report may be available, hence timing of responses to directions 1, 2 and 3 is uncertain, but obviously the time frames requested are not able to be met as the originally targeted Council meeting was 30 October 2023, for which the agenda closes on Friday 20 October 2023.

As direction 3 and 4 require a response from the planning authority, the next available council meeting at which a decision could be sought is 20 November 2023, with a submission provided to the Commission within 7 days, that is by 27 November. This revised timing would require the BHM Plan to ideally be provided to council by 3 November 2023.

In relation to directions 5 clarification of the recommended changes to condition 2 as outlined in Attachment 4 of Council's Section 40K report, could be provided by 9 November. However, to ensure consistency of all submissions, it is requested that an extension is granted for responding to all directions, as follows:

Direction 1 revised due date 3 November 2023, and

• Directions 2,3,4 and 5 revised due date 27 November 2023.

Could you please advise whether the revised timing is acceptable to the Commission.

Given the council meeting schedule previously outlined, it would be appreciated if you could provide a response by COB Tuesday 17 October.
