Huon Valley Council Draft Local Provision Schedule (LPS) – folio of the Register CT No., land at Street address in the Cluster proposed rezoning

State-wide planning reform required all local government areas to develop a Local Provision Schedule (LPS), which along with the State Planning Provisions, forms the Tasmanian Planning Scheme.

The Huon Valley Council is in the process of applying the Local Provisions Schedule to the municipality. The Huon Valley draft LPS was exhibited as part of the process. This included some text-based documents and maps showing where different zones and codes apply. Information about the Huon Valley LPS can be accessed on the <u>Tasmanian Planning Commission website</u>.

Your land at *Street Address*, folio of the Register *CT No.*, was exhibited as *Exhibited Zone*. During the exhibition period some landowners sent representations about their land to the Council. The Council was required to compile a report (called 35F) of responses and recommendations about each representation.

The Commission has undertaken hearings into the matters raised in each representation. At a hearing held earlier this year, the rezoning of a group of properties, at the *Cluster* including your land was discussed. The Commission directed the planning authority to confirm the extent of the cluster to be included in the proposed change. As a consequence, the following zone revision from the exhibited *Exhibited Zone* to the *Proposed Zone* is now being considered.

The Commission is seeking to ascertain whether affected landholders support the proposed zone revisions. Included with this letter is a copy of the relevant State Planning Provisions zone chapters for comparison purposes and a form on which to provide your response to us. For your response to be included in the Commission's considerations it needs to be provided by **DATE**. It is important that the response reflects that of all registered owners of the property. It would be appreciated if you could provide your advice in writing by completing the attached form and returning by electronic mail or mail.

Should you wish to, the zoning of your land could be discussed at a hearing. If you want to participate in a hearing, please fill in and return the hearing attendance form (attached) and you will be advised on the date and time. Hearings will be held in the Council Chambers in Huonville and are likely to take place in late November.

Please note that confirmation or otherwise of your agreeance to the change of zoning does not necessarily confirm the Tasmanian Planning Commission will alter the zoning of the land. The Commission will release the decision on the entire Huon Valley LPS after all the hearings and considerations have been concluded.
