Huon Valley draft Local Provisions Schedule (LPS) – Land at 154 Crouchs Hill Road, Lucaston, folio of the Register 152441/1 in the Lucaston Cluster proposed rezoning

State-wide planning reform required all local government areas to develop a Local Provision Schedule (LPS), which along with the State Planning Provisions forms the Tasmanian Planning Scheme.
