## **Good Morning**

I am requesting an extension of time in relation to **Planning Authority 2** – Directions Schedule for George Town LPS.

Planning Authority 2 directions are as follows. A response was due Friday 12<sup>th</sup> May.

Provide a map/diagram showing how the Flood- Prone would be amended.
Clarify what areas of the Flood-Prone Hazards overlay a removed, and what the threshold for the removal shou
Response due Friday 12 May 2023.

Council met with Flussig Engineers last week. Flussig indicated that additional work would be required to work out the threshold for removal as required by the directions. Unfortunately Flussig cannot complete this work due to their current workload.

Council have discussed this work with Cameron Oakley from Hydrodynamica. Cameron has indicated he can assist with the directions. Council are currently waiting on a timeframe and costing for this work, however have expressed to Cameron the need to get it completed ASAP to comply with TPC directions.
