RE: DRAFT HUON VALLEY LOCAL PROVISION SCHEDULE (LPS) – LPS-HUO-TPS – DIRECTION 10

I write in response to the Commission's directions issued on 14 July 2023.

Direction 10 requested the following information:

Following the hearing of representation 387 (land at Abels bay):

- diagram showing the planning authority's recommended application of the Rural Zone (together with the Priority Vegetation Area overlay), Landscape Conservation Zone and the Agriculture Zone to that land located at Abels Bay, Randalls Bay and Deep Bay with particular focus on the zoning of folios of the Register 137938/3 and 226262/1);
- street addresses and title details for all land identified in the diagram; and
- contact details for all affected landowners (including postal addresses and email addresses, if available).

It is the intention of the Commission to contact affected landowners to seek their views in relation proposed zoning changes.

The Priority Vegetation Area overlay should only apply to areas of native vegetation.




Figure 6 Suggested application of Priority Vegetation Area overlay to CT 212013/1





Figure 7 Suggested application of Priority Vegetation Area overlay to CT 183842/1
