Draft Local Provisions Schedule – Representation for Rezoning of Department Land

Thank you for the opportunity to view and make comment on the Latrobe Council's Draft Local Provisions Schedule which has been advertised recently.

I would like to make a representation regarding the zoning which has been applied to some of the Department of Education properties located within your municipality.

Primarily I have concerns regarding the Latrobe Primary School, Latrobe High School and Port Sorell Primary School sites which have been zoned as General Residential, and the Sassafras Primary School and Andrews Creek Primary School which have been zoned as Rural Resource.

As these are key community facilities that provide educational or community-based services, it would be more appropriate that these sites be zoned Community Purpose.

Below is a list of the sites and the Property Identification Number (PID) that are owned by the Department of Education that I would like to have zoned as Community Purpose.
