RE: Circular Head Local Provisions Schedule Draft Amendment No. PSA 2023/1

Thank you for the opportunity to comment on the draft amendment in relation to the new Scenic Protection Areas under the Circular Head Local Provisions Schedule.

The Heritage Council supports the proposed amendment to scenic protection area to cover greater areas of Stanley Peninsula, Coastal Estuaries and Islands, Marrawah on northwest coast, Eastern Gateway, and central Sumac Lookout.

There are a number of places which are listed under the Tasmanian Heritage Register within the new scenic protection areas, including House and convict barracks (THR#891), Highfield (THR #892), Former Cable Station (THR #893), Stanley Burial Ground (THR #909), and Monateric (THR #940). The amended scenic protection area will enable expanded protection for significant landscape values arising from cultural heritage which are not covered by the heritage register. It is also recognized that high scenic quality of natural landscape will be protected from potential visual impact of new development or works on scenic values.
