## **PRIVATE TIMBER RESERVES**

I am pleased to advise that the Forest Practices Authority has approved your application for a Private Timber Reserve under the Forest Practices Act 1985.

Her Excellency, the Governor has been pleased to declare this area as a PTR and the Notification was published in the Tasmanian Government Gazette of 27/12/2023.

In due course the Register of Titles will record the declaration on your title(s).

Please be advised of your obligations under the Forest Practices Act that relate to the area(s) declared as Private Timber Reserves.

*"12(1) Where land has been declared as a private timber reserve in accordance with section 11(1), it shall be used only for establishing forests, or growing or harvesting timber in accordance with the Forest Practices Code and such other activities which the Board considers to be compatible with establishing forests, or growing or harvesting timber."*


*"40(1) For the purposes of this Act, a forest practices officer, on production of his warrant of authorisation as such, may at any reasonable time and with such assistants as he considers necessary enter and remain -*

*(b) on any private timber reserve to ensure that the reserve is being used for establishing forests, or growing or harvesting timber."*

Also, a Forest Practices Officer may, at any reasonable time, enter the property to inspect any forest operation to ensure that it is being carried out in accordance with the provisions of the Forest Practices Act and Code. The owner(s) are required to produce any documents or answer any questions in relation to that forest operation or Private Timber Reserve.

It would also be appreciated if you would inform this office if this land changes ownership.
